


## **Professional Paralegal**

Established in 2004, the Certified PP designation is an attainable goal for paralegals who wish to be identified as exceptional in all areas of law. The certificate is received after passing a one-day, four-part examination.

Successful completion of the PP examination demonstrates:

- A mastery of procedural skills and communication skills.
- An advanced knowledge of procedural law, the law library, and the preparation of legal documents.
- A working knowledge of substantive law and the ability to perform specifically delegated substantive legal work under an attorney's supervision.
- The ability to interact on a professional level with attorneys, clients, and other staff.
- The discipline to assume responsibility and exercise initiative and judgment while adhering to legal ethical standards at all times.
- Working under the supervision of a practicing lawyer or a judge, the Certified PP is expected to possess:
  - The same high standard of ethical conduct imposed upon members of the Bar.
  - Excellent written and verbal communication skills.
  - Knowledge and understanding of legal terminology and procedures, as well as procedural and substantive law.
  - The ability to assume responsibility, exercise initiative and judgment, and prepare substantive legal documents within the scope of assigned authority.
- Attaining this goal demonstrates dedication to professionalism and acceptance of the challenge to be exceptional. Personal motivation is necessary to attain such a goal

#### PP Examination Eligibility

Any person who has five years of experience performing paralegal/legal assistant duties is eligible to take the Professional Paralegal examination. (A candidate may receive a partial waiver of one year if he or she has a post-secondary degree, other certification, or a paralegal certificate; a candidate with a paralegal degree may receive a two-year partial waiver). Membership in NALS is not a requirement.

PART 2: Legal Knowledge and Skills
PART 3: Ethics and Judgment Skills
PART 4: Substantive law

#### **Examination Guidelines**

All four parts of the examination must be taken on the first attempt with the exception of PLS's for which only Part 4 Substative Law is needed. If you do not pass the entire examination on the first attempt, but do pass one or more parts, you may retake the part (or parts) you failed. All failed parts must be retaken at the same time. Effective March 2008, there will be a two-year limitation in which to retake any portion of the exam previously attempted but not passed.

Those passing the exam will receive a certificate which is valid for five years. Recertification is required every five years and may be achieved through the accumulation of continuing legal education hours and activities.

- A working knowledge of procedural law, the law library, and the preparation of legal documents.

#### PLS Examination Eligibility

Any person who has had three years of experience in the legal field may take the examination. Membership in NALS is not a requirement. A partial waiver of the three-year legal experience requirement may be granted for certain post-secondary degrees, successful completion of the ALS the basic certification for the legal professional, or attainment of other certifications. The maximum waiver is one year.





One way to demonstrate your preparedness for a career in the demanding field of law is by attaining the ALS designation. This designation is awarded after passing a four-hour, three-part examination.

Attaining this goal demonstrates your commitment and aptitude to succeed in the

ever-changing legal environment.

#### The ALS examination:

- Demonstrates the ability to perform business communication tasks.
- Gauges the ability to maintain office records and calendars, and prioritize multiple tasks when given real-life scenarios.
- Measures an understanding of office equipment and related procedures.
- Denotes an aptitude for understanding legal terminology, legal complexities, and supporting documents.
- Appraises a knowledge of law office protocol as prescribed by ethical codes

#### **ALS Examination Eligibility**

To sit for the examination, you must have completed one of the following: One year of general office experience; completion of an accredited office curriculum; or completion of a NALS Legal Training Course. Membership in NALS is not a requirement.

PART 3: Ethics, Human Relations and Judgment

#### **Examination Guidelines**

All three parts of the examination must be taken on the first attempt If you do not pass the entire examination on the first attempt, but do pass one or two parts, you may retake the examination part (or parts) you did not pass. All failed parts must be retaken at the same time. Effective March 2008, there will be a two-year limitation in which to retake any portion of the exam previously attempted but not passed.

Those passing the exam will receive a certificate which is valid for five years. Certification may be extended through continuing education, based on NALS guidelines, for one year.

## **Earn College Credits for NALS Certifications!**

NALS has successfully completed the five-year re-evaluation of the PLS examination, as well as the initial review of the ALS examination, by the American Council on Education (ACE). The evaluation of the PP examination is in process.

ACE had a team of content and technical experts selected from college faculty review the examination and concur that the examination is eligible for college-level credit recommendations.

The minimum score for awarding credit is usually 65 for each part; however, some colleges may require scores of up to 70. It is possible to earn up to 27 college-level credits. Although ACE makes the recommendation, it is up to the college or university you select to make the final decision on the number of credits awarded. They can accept some or all of the credits depending on their policies and procedures, your course of study, and other transfer credits.
