Prep Time: 10 min

8 oz. rotini pasta, uncooked

was on the movie "Life Goes On" (Planet Four Films) starring Obie Trice. Eva's most recent music performances include, (Detroit, MI) Club Sevin, Club Rain, Club Bleu (aired on local Detroit television), Silkies, The Limit Lounge, Hot Rock and Greektown Casino. EVA's performance at the Soul Cafe in Manhattan, NY was a smash as she tested new original material and did a rendition of "Fallin" with the band; it was off the hook! EVA also performed with Rap Artist SAINT, their newly recorded song "If You Believe" at



a new artist showcase at Club Cheetah in Manhattan, New York. EVA has been lending her vocals to many hip hop projects, recently recorded on the upcoming albums of Marco Polo (coming soon) and Brando and others of the Goodfella Crew out of Detroit. No boundaries is the only way to define EVA and her voice. Whether it's her music, voice, songwriting or acting ability. A diverse personality and talent is the make up for the passion for music that has always been evident as Eva has gone from singing, dancing, acting and songwriting in her childhood years to an international recording artist as a young adult. If you think your contribution would not amount to much, please rethink that thought: You can make a difference.
