INTRODUCTION

Sharon Woods' resume reads like a long interesting novel. When I began preparing this introduction I had truly underestimated her many achievements mainly because I see her daily, since we work together at the same office, and I never find time to ask the question of the day – so, what have you been busy with lately. Believe me, Ms. Woods is a busy person -- she is and has been involved in so many different arenas of professional growth. Allow me to begin to tell you her story: Ms. Woods received her Bachelor's Degree and graduated Magna Cum Laude from the University of Detroit. Thereafter, she received a Juris Doctor Degree and graduated Summa Cum Laude from the University of Detroit School of Law. Presently, she is the managing member of the downtown Detroit law firm of Barris, Sott, Denn & Driker, P.L.L.C. She is also Chairperson of the Firm's Management Committee as well as Chairperson of the Firm's Litigation Department. Ms. Woods' practice is primarily in the area of complex business litigation. Ms. Woods is admitted to practice before U.S. Supreme Court, U.S. Court of Appeals for the Sixth Circuit; U.S. Federal Court of Appeals; United States Court of Claims and various United States district courts. Ms. Woods is an accomplished trial lawyer. In 1989 Ms. Woods was elected a Fellow in the American College of Trial Lawyers, an international

association of over 4,500 trial lawyers whose membership is limited to the top 10% of trial lawyers in each state or province and is by invitation only. In 2002, Ms. Woods was elected to the 16 Board of Regents of the American College – the first time in the 50 years of the existence of the American College that a female was elected to the Board of Regents. In 2003, Mrs. Woods was also elected a Fellow in the International Academy of Trial Lawyers, which is an organization where membership is also by invitation only and whose United States membership is limited to the top 500 trial lawyers in the United States! She is listed in The Best Lawyers in America and has been since 1991. Other professional accomplishments include: She serves as an Arbitrator for the American Arbitration Association. She is also affiliated with the Complex Litigation Panel. In addition to being a Member of the State Bar of Michigan, she is a Fellow with the American Bar Foundation and a member of the Historical Society of the United States District Court for the Eastern District and has also served in the past as one of its Trustees and President. She is a member of the Historical Society of the United States Supreme Court and served in the past as a State Chairman for this organization. She served, by gubernatorial appointment, as Counsel on the Board of Accounting of the State of Michigan. She served in the past on the Administrative Grievance Committee of State Board of Accountancy. She served as a Trustee for the Detroit Bar Association

Foundation, and has held the position of President-elect. She is a member of the American Law Institute. She is a director of the historical Detroit Club in downtown Detroit, has served on its board, and also served in the past as both its Vice President and President. Sharon Woods was one of the first women to become a member of The Detroit Club. Ms. Woods is also involved in numerous community organizations. In her spare time, she enjoys golf and scuba diving.

KEYNOTE ADDRESS  
OF SHARON M.  
WOODS, ATTORNEY  
AT LAW

I want to thank Mary Tortomose, the incoming President of the Detroit chapter of NALS, for this opportunity to share this special night with you and to be invited to address this group for a few minutes. Notwithstanding the May showers, I am aware that this is a Friday night and can assure you that I will be brief. My message tonight is direct - continue your mission and expand the audience for your message. Like many professional organizations, NALS while having a rich history has, in recent years, been called upon to tailor its mission and audience to respond to the changes experienced in our legal profession. And yet, the importance of belonging to an organization that is dedicated

to expanding the education and skills of its members while reaching out to welcome the relatively new category of legal support is increasing. The demands of the legal support position (both legal secretary and paralegal) have become more diverse. When I graduated from high school, several of my classmates elected to join the secretarial ranks. This required that they not only were able to present the appearance of a professional but that they have the highest level of typing skills, spelling skills, communication skills, work ethic and above all, patience. The requirements of the legal secretary were levels above the requirements of a secretary as it was expected that, in addition to the demands of a secretary, you understand the nuances of the legal forms and requirements for litigation, real estate, tax, and probate, to name a few. The ethical demands on all secretaries, but especially legal secretaries, have always been extremely high as, by the nature of your profession, you become privy to the most confidential of information of individuals and corporations. The demands for patience and understanding are also heightened as you often deal with people who have their financial viability or even their continued freedom and way of life at jeopardy.

As technology has advanced and the world of the law has become even more complex, so has the position of legal support become more complicated, stressful, and demanding. Multi-tasking has become the norm, not the exception, and the expectations from the legal support team have skyrocketed. Hollywood

even ventured into the world of trying to capture the demands upon the secretarial profession. Who can forget the remarkable roles of Goldie Hawn, Mary Tyler Moore and Lilly Tomlin in that remarkable movie, Nine to Five, which captured the ever expanding demands upon the secretary. Oh yes, technology! How did we function before the Xerox machine? And multi-tasking - it has become a way of life in the office! But with the onset of computer technology and the expanding scope of litigation and other practice areas, the concept of legal support, has greatly expanded the duties. Legal secretaries now have become administrative assistants and paraegal services have become an accepted addition to the legal team. However, the duties and distinctions of these two professionals are, at times, blurred. Especially in the area of litigation (which is my area of specialty), the representation of a client has become a team effort. With the expansion of available information, recognizing the potential and available sources of information, hunting down all leads for information, gathering that same information and assembling and presenting it in a winning format is now the business of the litigation team — comprised of lawyers, secretaries, now called administrative assistants, and paralegals. The importance of the legal support portion of the team is ever-expanding. With the expansion of discovery so that every letter, every e-mail, and every voice mail message is now swept into the world of discoverable information and the subject of possible sanctions for the inadvertent

deletion of this information looming, legal support is now being challenged to not only manage the retention of this information but is being called as witnesses to justify the actions taken in the preservation of this evidence. Your ability to recall with precision the preservation acts in discovery have profound impacts on litigation. These facts, of course, bring into clear focus the need for professional organizations such as NALS which can, and does, provide the guidance to its members on the ever-expanding ethical issues that confront its members. The challenges to your profession and mine are enormous! But the satisfaction we experience, when together we can guide our clients through the maze of the law, is overwhelming.

As the managing member of one of Detroit's 50 largest law firms, I know first hand the benefits that our legal support has received from membership in your organization. On behalf of my firm and, I am confident, I could include all the large law firms in metropolitan Detroit area, I salute NALS of Detroit on its long history and achievements. I challenge your organization to reach out to all of legal support in the metropolitan Detroit area so you, as a group, can bring them the benefits of affiliation with your fine organization. And, on this special evening, I congratulate your choice of a very special person in my life as your incoming President. Mary Tortomose is coming upon her 20<sup>th</sup> anniversary with our firm, but has not aged a day. She is as gracious today as she was when she walked in the door. She will be a

wonderful leader to your organization and I, and the entire firm she is employed at, are extremely proud of her and her executive officers.

Thank you for letting me share this special evening with all of you.
